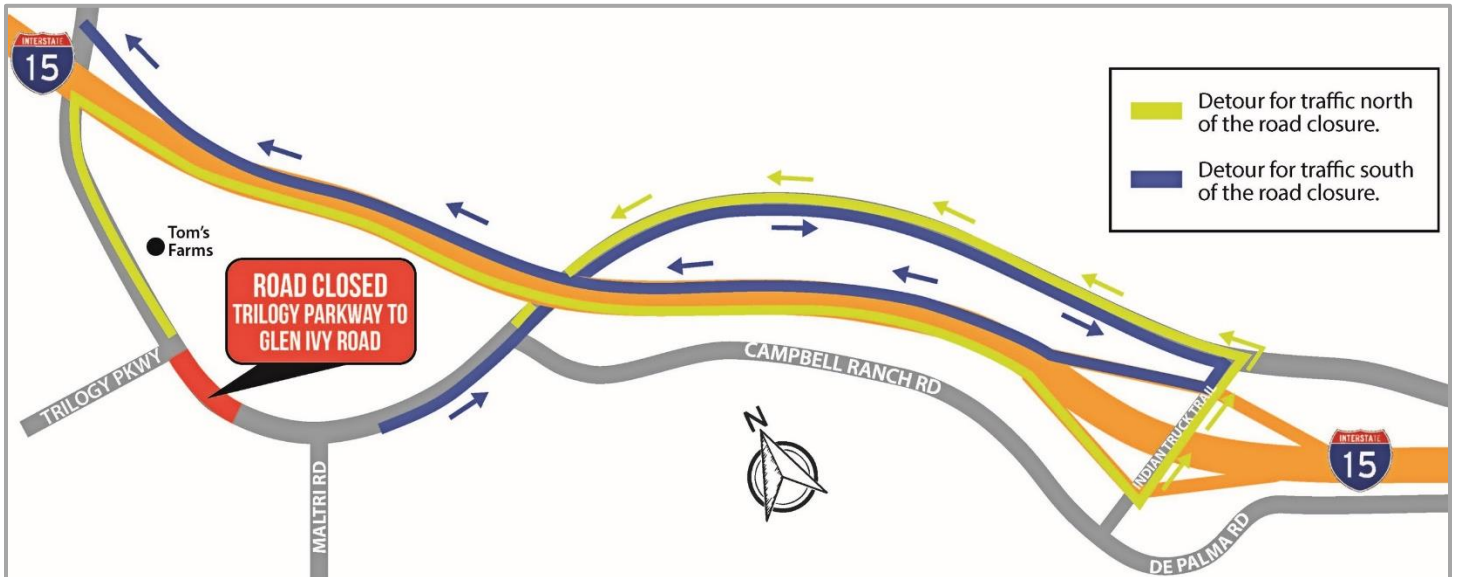




TCR CLOSURE SCHEDULED JULY 8 – AUG. 11

Temescal Canyon Road culvert will relieve flooding during rains

The long-awaited project to place a concrete box culvert under **Temescal Canyon Road** just north of **Glen Ivy Road** has finally been scheduled from **July 8 to Aug. 11**, according to **Patricia Romo**, director of the county's **Transportation Department**.

The \$335,000-project will allow **Coldwater Creek** drainage to flow under the roadway instead of over it during heavy rains. "But," Romo told the audience at last week's **MAC** meeting, "in instances of 50- or 100-year storms, water will still run over the road but for a much shorter duration because of the culvert."

Romo said she doesn't think the project will take five weeks -- "We allowed for delays due to unforeseen circumstances." To get the project completed as quickly as possible, she said the work is scheduled 24/7 with noise-generating construction to take place during daytime hours.

She said it was impossible to put the culvert in with only lane closures instead of a full road closure because of construction and environmental constraints to the narrow roadway and the need to relocate utilities.

The county's **Dennis Green**, who led the August 2017 community meeting to discuss the road closure, is again heading the project's public outreach. Fliers will be distributed to residents and businesses, and he is coordinating communication with all service providers including law enforcement, fire, ambulance and the county Transit Agency for the **CommuterLink** bus at **Tom's Farms**. Signage will be placed on the I-15 to let commuters know Temescal Canyon Road is closed and is not a feasible detour to avoid freeway gridlock.

The project was first scheduled in late 2016 but was postponed because of heavy rains and a delay from **Caltrans** in responding to the county's request for detour signs.

It was rescheduled mid-August 2017, but public concern over the road being closed while schools were in session caused the project to be postponed until summer of 2018. Last year the county made the decision to delay the project again and tag it on to the Temescal Canyon Road widening now in progress on the east side of the freeway.

The last postponement could be viewed as fortuitous because the **Holy Fire** erupted on Aug. 6 and the closure of TCR would have impeded the work of fire crews and the efforts of evacuated residents to leave the area.

Landfill undergoes annual review

The **El Sobrante Landfill Administrative Review Committee** (ARC), will meet at 10:30 a.m., **Wednesday, June 19** at the county's Department of Waste Resources, 14310 Frederick St., Moreno Valley.

USA Waste/WMI, owner of the landfill, is required to submit an annual report to the county's **Board of Supervisors** documenting its conformance with the conditions and mitigation measures imposed on El Sobrante.

The report is first vetted by the ARC, comprised of three county employees appointed for that purpose, and then by the **El Sobrante Citizen's Oversight Committee** (COC), for final review and comments.

The Department of Waste Resources in January created a COC newsletter which is published quarterly and provides updates on landfill-related topics. View the latest edition here:

Sheriff shares Temescal Valley crime stats for March, April, May

During the June 12 **Temescal Valley Municipal Advisory Council** meeting **Sgt. Glenn Warrington** of the **Lake Elsinore Sheriff's Station** gave a detailed report on Part I crimes that occurred here in March, April and May.

Part I crimes include serious felonies; Part II crimes are non-serious felonies and all misdemeanors.

He said the station received **393 calls** for service from Temescal Valley during May – 18 fewer calls than received in April.

Thirty-four calls in May were for Part I crimes. Here is the breakdown:

Assaults – 4 in March, 4 in April and 5 in May.

Burglaries – 8, 3 and 2.

Thefts – 9, 4, and 12.

Strong-armed Robbery – 1, 1 and 1.

Vehicle Theft – 4, 4 and 5.

Theft from Vehicle – 3, 4 and 9.

There were **4 arrests in March** – 1 felony and three misdemeanors. **April saw 3 arrests** – 2 felonies and 1 misdemeanor, and there were **13 arrests in May** – 3 felonies and 11 misdemeanors.

Vandalisms reported for March, April and May were **5, 5 and 3**, respectively. **Disturbing the Peace** calls numbered **35, 36 and 31**.

Time to again nominate TV as air-quality disadvantaged community

Temescal Valley hasn't given up its quest to have an air-quality monitoring station located here, according to **Jerry Sincich**, chairman of the **We Are Temescal Valley Development Committee**.

Sincich, as he did in April 2018, again is urging residents to nominate Temescal Valley as an air-quality disadvantaged community in need of air monitoring.

The **South Coast Air Quality Management District** last year held a series of meetings to let the public know about **AB 617** which encourages collaboration with and the identification of disadvantaged communities needing assistance in cleaning up the air. Meetings again are being held this year. (See the flier section of the newsletter for the meeting closest to Temescal Valley.)

While we didn't make the cut for the three communities selected last year, we're still being considered but need to re-nominate Temescal Valley. The SCAQMD makes the process easy with an online nomination form.

Question 11 asks why the nominated community is a good candidate. Here are a few reasons:

— Temescal Valley is located in a long, narrow valley between two mountain ranges bisected by the usually gridlocked I-15 freeway.

— Located here are several aggregate mines, asphalt and cement batch plants, and one of the largest landfills in the nation which uses incinerator ash as ground cover.

— The largest mines and the landfill operate 24/7.

— Several hundred trucks daily exit the freeway, spewing exhaust emissions and creating fugitive dust as they travel along

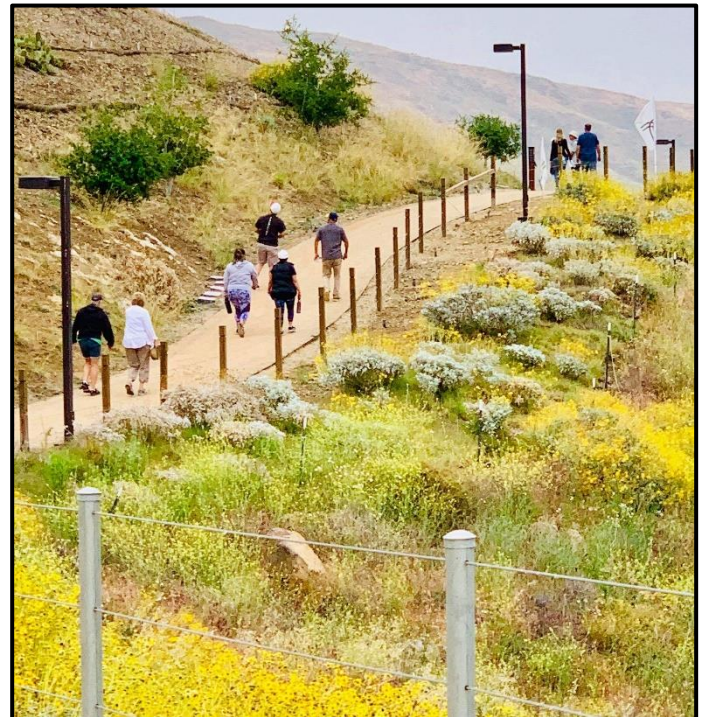
The entries were blindly judged – the entrants' names were removed from the photos prior to judging. The Best of Show winner was decided by a vote of people attending the Faire.

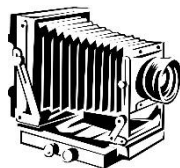

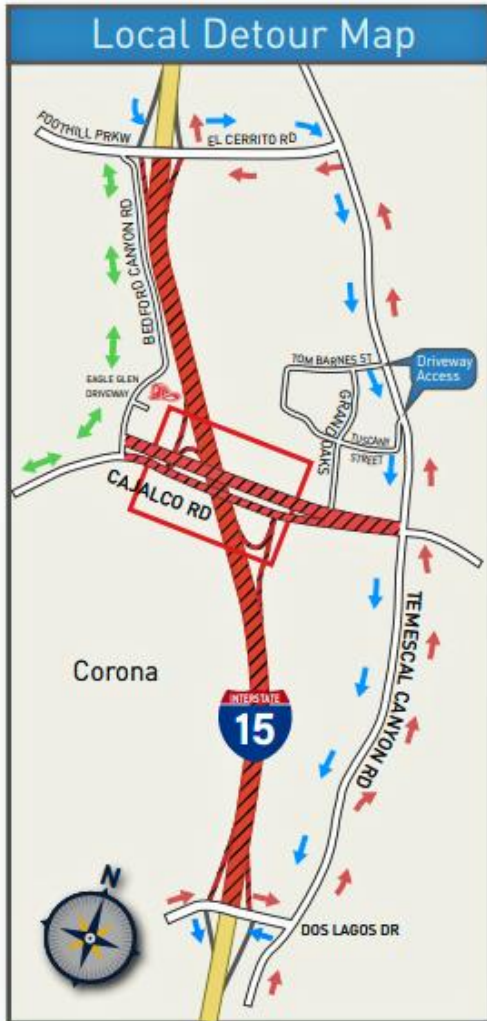

VAPING: WHAT PARENTS NEED TO KNOW

WHAT IS VAPING?

Vaping is the act of inhaling aerosol that is heated using an e-cigarette device.

WHAT IS AN E-CIGARETTE?

- E-cigarettes are known by many different names. They are sometimes called "e-cigs," "juuls," "mods," "vape pens," "vapes," "tank systems," or "electronic nicotine delivery systems."
- E-cigarettes can be made to look like regular cigarettes, cigars, or pipes. Many are made to be disguised by looking like pens, USB drives, and other everyday devices.



Juul and Suorin devices have surged in popularity among teens. They can be nearly indistinguishable from USB drives and contain high concentrations of nicotine and can be modified to contain marijuana.

WHAT ARE THE HEALTH EFFECTS?

98.7% OF VAPE PRODUCTS SOLD CONTAIN NICOTINE.

- Nicotine is HIGHLY addictive.
- Nicotine constricts blood vessels, which can lead to gum disease, lung disease, and retinal damage, much like smoking cigarettes.
- Using nicotine in adolescence can harm the parts of the brain that control attention, learning, mood, and impulse control.
- Juul devices use nicotine salt, which delivers the nicotine to the blood stream faster, leading to a higher chance of addiction.

BESIDES NICOTINE, AEROSOL CONTAINS CHEMICALS THAT CAN HARM THE BODY.

- These include cancer-causing chemicals and tiny particles that reach deep into lungs.
- Vape liquid contains flavoring such as diacetyl, a chemical linked to a serious lung disease; volatile organic compounds such as benzene, which is found in car exhaust; and heavy metals, such as nickel, tin, and lead.

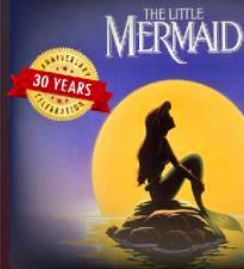

Introduction to California Recycling Legislation



[Assembly Bill \(AB\) 939- California Integrated Waste Management Act of 1989](#)

- Requires cities/counties to divert a minimum of 50% of the solid waste landfilled by the year 2000.
- The unincorporated communities of Riverside County, which includes Temescal Valley, continues to meet the 50% waste diversion requirements.



[AB 341 - Mandatory Commercial Recycling \(enacted 2011\)](#)

- Established a statewide 75% recycling goal by 2020.
- Requires most businesses and multifamily units to arrange for recycling services.

[AB 1826 - Mandatory Commercial Organics Recycling \(enacted 2014\)](#)

- Requires businesses to recycle organic waste, with the goal of reducing disposal of organic waste to meet the 75% recycling goal (established under AB 341) by 2020.
- As of January 1, 2019, most businesses and multifamily units must arrange for recycling services for organic waste.

[Senate Bill 1383 - Short-lived Climate Pollutants \(enacted 2016\)](#)



- Requires a reduction of organic waste disposal by 50% by 2020 and by 75% by 2025.
- CalRecycle is developing regulations to meet this requirement- food recovery programs, more organics recycling, increased education and outreach, procurement requirements, etc.
- In Riverside County, the Department of Environmental Health is coordinating with the waste haulers and other stakeholders to address SB 1383. In anticipation of the new rules, in summer 2019, WMI will be providing green-waste collection bins to Temescal Valley residents.
